Chairman's Annual Report 2008

1. BOARD OF DIRECTORS:

The Company was incorporated on 15 March 2007 and six Directors were appointed three by Women's Lacrosse Australia Ltd Fiona Clark, Shelley Maher and Paul Mollison and three by Lacrosse Australia Ltd Mavis Owens Allan Frederick and David Fox.

It has been a privilege to serve Australian Lacrosse Australia and the Lacrosse community as Chairman during the past period which has been difficult but progressive.

Unification and the realization of one body controlling Lacrosse in Australia will come a step close and with the transfer of responsibilities to the new body Australian Lacrosse Association Ltd at the AGM of Lacrosse Australia Ltd on 21 November 2008 and the AGM of Women's Lacrosse Australia Ltd on 8 December 2008.

Hopefully both will succeed and we will see one Governing Body emerge. To be in full operation for the 2009 season

Unification has been on the Agenda for many years and has occupied a considerable amount of time but for the continuation of our support from the Australian Sports Commission it must be in proceed with out delay.

Our two year transition ends on 14 March 2009 and I hope that the new Body complete with its broadly elected Board can be well and truly in operation by that date.

At the International Level I witnessed the Unification of Men's and Women's Lacrosse in Lahti Finland on 7 August 2008.

I still have reservations that the new body has properly addressed the future funding of a significant international body unification at this level has been achieved and we will watch with interest for the benefits to flow.

I place on record my thanks to the Board members and the many volunteers at all levels that that have assisted Lacrosse in so many ways during the past year.

2. MEETINGS:

I thank Directors for the time sacrificed from their day jobs to enable meetings to take place.

3. BUSINESS PLAN:

A review of the Business Plan was undertaken during the year and the review of this and further refinement will be the first major task of the new Board.

4. INTERNATIONAL Scene:

Fiona Clark from Perth retired as International President of IFWLA and Shelley Maher was appointed to the Board of the New International Body For Lacrosse FIL.

Peter Hobbs from Adelaide retired as International President of ILF and Leighton Beamsley retired from the position of Executive officer of ILF.

Alan Frederick continues on the Development Committee of the Federation of International Lacrosse.

The Final sessions of the ILF and IFWLA meetings were held in Lahti Finland and the first meeting of the International Body Federation of International Lacrosse was held in Lahti.

Shelley Maher represented Australia at the IFWLA meeting and I represented Australia at the ILF and FIL meetings.

I thank those who made a great sacrifice to ensure our representation at the International level in 2008.

We are exceedingly appreciative that Lacrosse is still included in those sports which the Australian Government continue to fund through the Australian Sports Commission.

However our Sports Commission grant is a Sport Development grant and expenditure on the elite programme and International competition is the not the purpose of this grant and not a permitted application of these grant funds.

6. COMPETITIONS:

Full Details of the Competitions and Activities of both Women's and Men's Lacrosse in Australia are contained in the Annual Reports of Women's Lacrosse Australia Ltd and Lacrosse Australia Ltd which have been circulated on 21 October 2008 and 18 November 2008.

I commend these reports to you.

I place on record the thanks of Australian Lacrosse Association Ltd to all those that supported Lacrosse during the period.

8. LIAISON:

8.1 Australian Sports Commission

Communications with the Australian Sports Commission continue to be maintained through our ASC Liaison Bob Kershaw.

I record my thanks to Bob for the guidance, assistance and perseverance which he has provided to Australian Lacrosse Association and Lacrosse Australia during the past year, particularly in relation to further assistance and tolerance shown with unification.

Directors' Meetings

During the year four Directors' meetings were held and all directors attended each meeting. Alan Frederick was overseas representing Australian Lacrosse at the World Under 19 Series in July 2008 and was not present for the July meeting.

Operating Result

The Company returned a surplus for the 2008 Financial Year of \$456 which followed a break even for the period 15 March 2007 to 30 June 2007.

The surplus was due to interest on funds at bank.

The balance of the Australian Government Sports Commission Grant for the year ended 30 June 2008 has not been received at this stage because on the failure to complete the acquittal process which should be completed by the date of the Annual General Meeting.

The new Board needs to address resourcing of the administration functions of the Unified Body and allocate sufficient resources to pay for an executive officer to perform the multitude of administration.

Since Incorporation I have performed all of these tasks in an honorary capacity and this has been a huge commitment and accounts for the finalization not being perhaps at the level that some might have desired.

I make no apology for the actions that have not been completed.

I have expended a huge effort on these functions in contrast to some who have just been able to attended Board meetings.

The Company is exempt from Australian Income Tax

Review of Operations

A detailed review of the operations of the Lacrosse Activities are contained in the reports of Women's Lacrosse Australia and Lacrosse Australia Annual Reports.

Results of operations for the year ended 30 June 2008 and the financial position of Australian Lacrosse Association Ltd at 30 June 2008 are as shown in the attached financial statements.

Significant Changes in the State of Affairs

No significant changes in the Company's state of affairs occurred during the financial year.

Principal Activities

The principal activity of the Company during the course of the financial year was that of a National Sporting Organization. No significant change in the nature of this activity occurred during the year.

After Balance Date Events

No matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the Company, the results of those operations, or the state of affairs of the Company in subsequent financial years except for the proposed motions to be considered at the Annual General meetings of Women's Lacrosse Australia and Lacrosse Australia to transfer the powers of administration and management of the day today conduct of Men's Lacrosse to Australian Lacrosse Association Limited the body now recoginsed by the Australian Sports Commission as the National Governing Body for Lacrosse in Australia.

Note 1: Statement of Accounting Policies

The financial report is a general-purpose financial report that has been prepared in accordance with Australian Accounting Standards, Urgent Issues Group Consensus Views and other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001.

The financial report covers Australian Lacrosse Association Ltd as an individual entity. LAČROSSE AUSTRALIA LTD is a company limited by guarantee, incorporated and domiciled in Australia.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets. All Revenue is shown net of Goods and Services Tax (GST).

The following is a summary of the material accounting policies adopted in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Income Tax

The company is exempt from Income tax.

Tax-effect accounting whereby the income tax expense is based on the profit from ordinary activities adjusted for permanent differences has no applicability to the company whilst it remains exempt from Income Tax.

There are no future income tax benefits brought to account.

Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis.

Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

a) Plant and equipment

The carrying amount of plant and equipment is reviewed annually to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining the recoverable amounts.

The expected net cash flows from investments have not been discounted to their present value in determining the recoverable amounts.
